EXHIBIT "A" to Bylaw No. 7/2016

AGREEMENT RESPECTING THE JOINT FUNDING OF THE MARYFIELD RINK

Between: The Rural Municipality of Maryfield No. 91 of the Province of Saskatchewan And

The Village of Maryfield, of the Province of Saskatchewan.

This Agreement Witnesseth As Follows:

- 1. The parties to this agreement agree to provide financial contributions in the amount of 50% of the insurance premiums for the Maryfield Rink.
- 2. The parties to this agreement agree that the amounts payable by the R.M. of Maryfield No. 91 shall be paid to the Village of Maryfield on or before the 30th day of December in each year.
- 3. The Village of Maryfield hereby agrees to provide to the R.M. of Maryfield No. 91 such documentation and accounting necessary under the Inter-Municipal Recreation Program to substantiate the amount of monies expended upon the recreational facilities mentioned within this agreement, such documentation to be provided on or before the 31st day of December in the year of the expenditure.
- The R.M. of Maryfield No. 91 and the Village of Maryfield agree that the Maryfield Rink will be available for all residents of each municipality on an equal opportunity basis.
- This is understood and agreed that this agreement shall be continuous, and shall be reviewed jointly by the parties to the agreement annually. The agreement may be terminated by either party by giving thirty (30) days written notice to the other party.
